Chair Smith made a motion to adjust Line 41501.210.00 Health Insurance to \$20,178. Member Fournier seconded the motion. All members were in favor. Vote: 6/0/0

Chair Smith made a motion to recommend the **Budget committee total of \$5,798,713, a 10.83% increase** in Warrant Article 2022-06 Operating Budget.

Member Sakakeeny seconded the motion. Due to long discussions, the vote was deferred.

Chair Smith made a motion to add \$2,671 to the Elder Services COLA Lines 42151.110.02 to \$3,105, 42151.110.02 to \$72,450, 42151.220.00 FICA to \$1,684, and 42151.225.00 Medicare to \$1,090. Member Torosian seconded the motion. All members were in favor. Vote: 6/0/0

Member Torosian made a motion to reduce Line 45501.110.02 Library Asst. Dir. by \$1465. Member Sakakeeny seconded the motion. Five members were in favor. Vote: 5/0/1

Chair Smith made a motion to recommend that **Warrant Article 2022-06 Operating Budget** for an amount of \$5,799,919 for a 10.85% increase.

Member Sakakeeny seconded the motion. Motion did not pass. Vote: 3/3/0

Vice Chair Barker made a motion to reduce **Line 43122.110.01** Labor from \$47,642 to \$38,422. **Member Torosian** seconded the motion. Four members were in favor. **Vote: 4/0/2**

Member Torosian made a motion to reduce **Line 43122.430.00 Equipment Repairs** from \$10,000 to \$9,000. **Member Fournier** seconded the motion. Five members were in favor. **Vote: 5/0/1**

Member Fournier made a motion to reconsider voting on the budget. Vice Chair Barker seconded the motion. All members were in favor. Vote: 6/0/0

Chair Smith made a motion to recommend to the voters a total budget of \$5,789,699, a 10.66% increase from last year.

Member Fournier seconded the motion. Four members were in favor. Vote: 4/2/0

Chair Smith made a motion to recommend to the voters a total Default Budget of \$5,731,755, a 9.55% increase over last year's Default Budget.
Member Fournier seconded the motion. Five members were in favor. Vote: 5/1/0

Member Fournier made a motion to approve the minutes as amended. Member Sakakeeny seconded the motion. All members were in favor. Vote: 6/0/0

Minutes for 01/20/2021

Member Torosian made a motion to approve the minutes as written. Member Fournier seconded the motion. All members were in favor. Vote: 6/0/0

Member Torosian made a motion to rescind votes by the Budget Committee on Warrant Articles 2022-19, 2022-20, 2022-21 because they are not true expenditure warrants; therefore the votes are not valid.
Member Fournier seconded the motion. All members were in favor. Vote: 6/0/0

Vice Chair Barker made a motion to recommend to the voters a total **Default Budget of \$5,523,423,** a 5.57% increase from last year.

Member Fournier seconded the motion. All members were in favor. Vote: 6/0/0

Chair Smith made a motion to recommend that **Warrant Article 2022-06 Operating Budget** for an amount of \$5,789,599 for a 10.66% increase with a Default Budget amount of \$5,523,423, a 5.57% increase. **Member Fournier** seconded the motion. Four members were in favor. **Vote: 4/2/0**

Chair Smith made a motion to adjourn. Member Torosian seconded the motion. All members were in favor. Vote: 6/0/0
