Town of Atkinson Budget Committee Meeting Minutes January 20, 2009

Attending: Jim Blackadar – Chairman, Dave Paquette Vice Chairman, Steve Giangregorio, Fred Thompson, Harold Morse, Mari Anne Princiotta, and Bill Friel ex-officio

Jim called the meeting to order at 6:49 PM. Jim stated that the plan for the evening is to review the last 3 warrant articles and make a determination on them prior to the public hearing. The first order of business was to review the minutes from the January 13, 2009 meeting.

Steve motioned to accept the minutes as presented/Seconded by Dave/Unanimous 5-0 (Harold abstained).

The Board reviewed the last 3 Selectmen's warrant articles to either recommend or not recommend the warrant. The warrant articles are as follows:

Article 2009-9 Operating Budget

Fred motioned to recommend the Operating Budget warrant article/Seconded by Mari Anne/motion passes 5-1.

Article 2009-10 Shim and Overlay Roads

Fred motioned to recommend the Shim and Overlay Roads warrant article/Seconded by Dave/Unanimous 6-0.

Article 2009-7 Multiple-Year Collective Bargaining Agreement

Bill provided the Board with copies of the contract and a breakdown of the costs involved. The agreement calls for a 1% COLA in 2009, a 2.5% COLA in 2010 and a 3 % COLA in 2011.

Fred motioned to recommend the Collective Bargaining Agreement warrant article/Seconded by Dave for discussion.

Dave indicated that in the agreement the officers will still be getting pay increases based on the steps outlined in the contract. He also reminded the Board that the Selectmen did not authorize any COLA increases this year but had given several raises. It was also determined through discussion that if the warrant does not pass the existing contract would remain in place which still accounts for step increases. Fred withdrew his motion.

Dave motioned to not recommend the Collective Bargaining Agreement warrant article/Seconded by Steve/motion passes 5-1.

At this point Jim opened the public hearing (7:37 PM) for the purpose of presenting the 2009 operating budget, revenue and the Board's decisions on the warrant articles that involve the raising and appropriating of funds. The operating budget, revenue and warrant articles are attached to the minutes. There were no recommendations from the public to make any changes. Jim closed the public hearing at 8:45 PM.

The Board determined that there wasn't a need to meet prior to Deliberative Session. The Board then reviewed and signed the MS 7. Jim will forward it to DRA for review and will post it on Monday. The Board will meet after Deliberative session to update the MS 7 for any changes. Jim reminded the public that Deliberative Session is January 31, 2009 at 10:00 AM at the Atkinson Academy Dyke Auditorium.

Fred motioned to adjourn the meeting/Seconded by Dave/Unanimous 7-0. Jim adjourned the meeting at 9:00 PM.



Article 2009-18 Modify Elderly Exemption

Shall we modify the elderly exemptions under the provisions of RSA 72:37-a and RSA 72:39-b from property tax in the Town of Atkinson, based upon assessed value, for qualified taxpayers, to be as follows: for a person 65 years of age up to 75: \$100,000.00; for a person 75 years of age up to 80: \$150,000.00; for a person 80 years of age or older: \$200,000.00? To qualify, the person must have been a New Hampshire resident for at least **three (3)** consecutive years, own the real estate individually or jointly, or if the real estate is owned by such a person's spouse, they must have been married and living together for at least five (5) years. In addition, the individual taxpayer must have a net income of not more than **\$34,700.00**, or, if married, a combined net income of not more than **\$43,500.00**; and own net assets not in excess of \$100,000, excluding the value of the taxpayer's residence. New exemption qualifications become effective for the 2010 property tax year.

Article 2009-20 Close Digital Communications' Capital Reserve Fund

Shall the Town vote to discontinue the Digital Communications Capital Reserve Fund, established in 2001 for the purpose of replacing the Police Department's with new mandated digital equipment? This fund has had no balance since 2002.

Article 2009-21 Close Sawyer Avenue Capital Reserve Fund

Shall the Town vote to discontinue the Sawyer Avenue Capital Reserve Fund, established in 1995 for a reconstruction project at the intersection of NH Route 121 (Main Street) and Sawyer Avenue, in July 2009, remaining money to be transferred to the Town's General Fund? This fund had a balance of \$3,069.56, as of January 2, 2009.

Article 2009-22 Solar Exemption

Shall we adopt the provisions of RSA 72:62 for an exemption for property tax purposes from the assessed value of real property equipped with a solar energy system, for the purpose of heating, cooling or providing electricity, which exemption shall be in the amount of the equipment plus installation?

Article 2009-24 Library's Authority to Accept & Expend Money

Shall the town accept the provisions of RSA 202-A:4-c providing that any town at an annual meeting may adopt an article authorizing indefinitely, until specific rescission of such authority, the public library trustees to apply for, accept and expend, without further action by the town meeting, unanticipated money from a state federal or other governmental unit or a private source which becomes available during the fiscal year? If this Article passes, it will become effective on January1, 2010.

Article 2009-25 Library's Authority to Accept Gifts of Personal Property

Shall the town authorize the public library trustees to accept gifts of personal property, other that money, which may be offered to the library for any public purpose under RSA 202-A:4-d, and such authorization shall remain in effect until rescinded by a vote of town meeting? Prior to the acceptance of any gift valued at over Five Thousand Dollars (\$5,000),

the public library trustees shall hold a public hearing on the proposed acceptance. If this Article passes, it will become effective on January 1, 2010.

Article 2009-27 Petition: Increase Veterans' Tax Credit

By Petition: Shall the Town increase the Veterans' Tax Credit to Five Hundred Dollars (\$500.00) as allowed by the State of New Hampshire?

Article 2009-28 Petition: Mail Tax Cards

By Petition: "To see if the Town will vote to direct the Board of Selectmen/assessor to immediately mail a copy of any changes made to a taxpayer's property tax card, with the reason(s) as to why it was changed. (This would allow every taxpayer to have advanced notice to any changes that would effect their tax bill.). When passed, this warrant article will become effective immediately."

Article 2009-29 Petition: Posting Tax Information

By Petition: "To see if the voters will vote to direct the selectmen/assessor to post all property tax cards information on the town web site, so taxpayers will not have to take a day off from work when they need that information. When passed, this warrant article will become effective immediately."

Article 2009-30 Petition: Restricting Legal Fees

By Petition: "To see if the voters will vote to prohibit the selectmen from spending taxpayer money on the personal legal fees of public officials personal legal fees for which the taxpayers have no direct liability for and to prohibit the unwarranted payments for legal advice not pertaining to town business When passed, this warrant article will become effective immediately."

Article 2009-31 Petition: Improve Elderly Services

By Petition: "To see if the voters of Atkinson will vote to expand Elderly Services to provide services to all residents at least 60 years of age; and to all residents with disabilities with no age restriction. To restrict the spending of the Elderly Services budget and Town managed donations, to services directed at the improvement of the health, well-being and protection of the qualified residents. Services are to include rides to medical appointments, and medical devices not already available through insurance or other welfare organizations. To further direct the Elderly Affairs Director to seek out other available State and Federal assistance, such as, but not limited to, NH Fuel Assistance and Meals on Wheels and to post such information at the Town Hall in a conspicuous location. To further direct the Director of Elderly Affairs to post instructions to qualified residents as to how to request and schedule services, in a conspicuous location at Town Hall. To further direct the Elderly Affairs Director to seek out and manage a staff of volunteers to assist the elderly with non-funded assistance such as, but not limited to, shoveling snow and well-being checks. When passed, this warrant article will become effective immediately."

Article 2009-32 Petition: Full Time Police Chief

By Petition: "To See if the voters will direct the selectmen to Advertise; direct; screen and interview candidates using the State Police interview unit, to conduct the screening process, and hire the MOST QUALIFIED by objective standards of; education, and time in service (minimum qualifications are; a Bachelors degree in Criminal Justice, and at least 15 years of certified service on a civil police force) candidate for the position of full time police chief. Said position to encompass the duties of the current part-time chief, and the current full time administrative Lieutenant, with salary commensurate with experience and having benefits the same as the current Atkinson Police Lieutenant and will have a starting salary in the range of \$60,000, plus the commensurate benefits. The selectmen are to begin this process within 14 days of this article being passed by the voters, and this process MUST be completed within 60 days of the passage of this article. Advertisements for this position are to run in at least 3 newspapers of general circulation in the Town, for at least 14 days."

Article 2009-33 Petition: Elect the Planning Board

By Petition: "To see if the voters of Atkinson will vote to restrict the staffing of the Planning Board to Elected members only. Elected members of the Planning Board will be prohibited from conducting business with the Town during their session in office. When passed, this warrant article will become effective at the next Town Meeting."

Article 2009-34 New Powers

Shall the Town vote to adopt the provisions of RSA 36-A: 4-a, I(a) to authorize the Conservation Commission to expend funds to purchase interests in land outside the boundaries of our municipality, subject to the approval of the local governing body?

Article 2009-35 Town Forest

Shall the Town vote to designate the Sawyer 4-H parcel (Map 4 Lot 11) as an Atkinson Town Forest, to be managed by the Conservation Commission under the provisions of RSA 31:112?
