Town of Atkinson Budget Committee Meeting Minutes January 14, 2010

Jim called the meeting to order at 7:00 PM. The Board addressed each warrant article in order and made the following motions:

1. \$1,000 to televise all Conservation Committee meetings.

Fred motioned to Recommend this warrant article/Seconded by Bill/Unanimous 5-0

2. \$1,000 to televise all Library Trustee Meetings.

Fred motioned to Recommend this warrant article/Seconded by Bill/Unanimous 5-0

3. \$10,000 for video streaming equipment.

The Board requested that the Tech Committee provide a road map outlining the direction of the Town's website, if provided, the Board will consider changing their recommendation.

Fred motioned to NOT Recommend this warrant article/Seconded by Dave/Unanimous 5-0

4. \$18,000 to build a new cable studio.

Bill provided the cost estimate for the new studio. It was determined that there is enough floor space to handle the Town's Servers as well.

Fred motioned to Recommend this warrant article/Seconded by Bill/Unanimous 5-0

5. \$6,500 for Elderly Affairs vehicle.

Dave expressed his concerns that this could lead to increased costs over time. It was noted that this will eliminate one existing vehicle leaving the fleet at 3. This vehicle will come with a 3 year maintenance plan.

8. \$15,000 Highway Expendable Trust.

Jim motioned to Recommend this warrant article/Seconded by Fred/Unanimous 5-0

9. \$35,000 Kimball House Siding and Windows

Bill informed the Board that this is and estimate developed by Bill Friel and should be enough to complete the siding and start the windows. The Building is under the control of the Library Trustees. The exact materials and style of windows has not been determined.

Bill motioned to Recommend this warrant article/Seconded by Fred/Motioned failed 2-3

The Board requested that estimated costs be provided. The Board will consider changing the recommendation at Deliberative Session.

10. \$46,460 Mosquito Control Expendable Trust.

Fred motioned to Recommend this warrant article/Seconded by Jim/Motion passes 4-1

13. \$5,000 Capital Reserve for Woodlock Park.

Dave motioned to NOT Recommend this warrant article/Seconded by Fred/Unanimous 5-0

Fred motioned to NOT Recommend this warrant article/Seconded by Dave/Motion passes 4-1

15. 166,606 for Shim and Overlay of 8 roads (Mosher, Stage, Rocking Chair, Cottontail, Pebble Brook, Leroy, Pages and Bittersweet)

Jim motioned to Recommend this warrant article/Seconded by Bill/Unanimous 5-0
