Chair Smith called the meeting to order at 7:02 p.m.

**Member Sakakeeny** has not spoken with the Fire and Police Chiefs or Animal Control since his last report. He feels the next step is to wait until he receives guidelines about the budget.

**Chair Smith** said the Dept. Heads should have received a copy of the spreadsheet that shows what was approved by the voters in March.

**Administrator Cressman** asked the Dept. Heads to submit budgets to him by late-August, early-September which he will review with them by late-September, early-October.

**Member Torosian** has been in touch with the Town Clerk, Tax Collector, Cemetery, Conservation and Building Inspector Depts.

**Member Malo** sent a copy of the draft form for donation organizations to each Budget Committee Member.

**Chair Smith** said that the Budget Committee will keep the Board of Selectmen in the loop regarding this subject per Administrator Cressman's request.

**Vice Chair** made a suggestion about editing the wording to the draft document.
