Chair Smith called the meeting to order at 7:00 p.m.

Agenda: Reading RTK Checklist, Attendance, Selectmen Liaison's Report, Proposed Numbers and Possible Adjustments

Chair Smith read the public notice regarding COVID-19.

Attendance was taken.

Checklist Supervisor Murphy reported the following:

- The total budget requested is \$6,519.00
- \$4,932.00 for salaries, FICA, and Medicare
- Labor is down which is \$600.
- The cost for running supervisors group is higher than previous years.
- When the budget is depleted, one or more supervisors are not paid for the rest of the year.
- The Board of Selectmen approved an increase in pay.

Member Malo asked if it was possible to hire a clerk to relieve the clerical responsibilities from the supervisors and lessen the hours of the supervisors.

Checklist Supervisor Murphy said she would look into that suggestion but was not sure it would be implemented before the budget deadline.

Member Malo recommended implementing the suggestion even if it does not make the deadline. If there is a surplus in the budget, it could be returned to the general fund.

Member Torosian stated that, generally, elected official increases should go on a warrant.

Checklist Supervisor Murphy said she would be open to doing it that way.

Selectman Worden stated that the Town Council had established a prior history of not going to warrant for an elected official for pay raises.

Member Torosian stated that he respectfully disagrees with Town Council and would like to go on record to say that he believes it should be put on a warrant.

Chair Smith made a motion to approve the amount requested.

Member Malo seconded the motion. All members were in favor. Vote: 5/0/0

Conflict of Interest Chairman Artus reported the following:

• Referring to the Conflict of Interest Ordinance, Section VII, Item I, the Conflict of Interest Committee would like to add money to the budget to be able to access professional legal advice.

After much discussion among the members and Selectmen liaison, it was decided that further information is needed before making a decision. They advised to meet again before the Warrant meeting.

Chair Smith made a motion to increase **Line 42202.110.01** FD Chief's Salary to \$53,360 which will include FICA, Medicare, and Retirement.

Member Fournier seconded the motion. All members were in favor. Vote: 6/0/0

Member Fournier made a motion to change **Line 42201.110.04** F/T Staff to \$81,600 which will include FICA, Medicare, and Retirement.

Chair Smith seconded the motion. All members were in favor. Vote: 6/0/0

Member Torosian made a motion to reduce Line 42201.210.00 FD Health Insurance to \$30,088.

Chair Smith seconded the motion. All members were in favor. Vote: 6/0/0

Member Torosian made a motion to change **Line 42201.430.00** FD Hydrants/Water Contract to \$18,400. **Chair Smith** seconded the motion. All members were in favor. **Vote:** 6/0/0

Member Torosian made a motion to approve the Fire Department Lines that have not already been adjusted to the proposed lines.

Chair Smith seconded the motion. Five members were in favor; one member abstained. Vote: 5/0/1

Member Fournier made a motion to approve all Lines for the Board of Selectmen, Town Administrator, and Clerical as submitted.

Member Torosian seconded the motion. All members were in favor. Vote: 6/0/0

Chair Smith made a motion to keep **Line 41305.110.00** Total Conflict of Interest at \$107 as initially proposed.

Member Torosian seconded the motion. Five members were in favor; one member abstained.

Member Torosian made a motion to keep the Committee Support and Energy Commission lines as proposed.

Member Fournier seconded the motion. All members were in favor. Vote: 6/0/0
